

# COVID RISK MITIGATION

## *The Silver Gold Alhambra Fall Event September 2020*

***In Alberta we are permitted to gather with up to 200 people outdoors to partake in athletic activities that allow for Safe Physical Distancing (SPD). Regulators and the equestrian industry have provided us with guidance which allows us to operate our competitions safely.***

***In an effort to ensure your safety and the safety of others we require participants and spectators to agree to the following prior to arrival at the scheduled clinic:***

- **Rider/parent/spectator may not attend if:**
  - They have returned in the past 14 days, from travel outside of Canada
  - If they are or have been in close contact of a person who tested positive for COVID-19 in the last 14 days
  - If they are diagnosed with COVID-19
  - If they experience any symptoms such as: a cough, fever, shortness of breath/difficulty breathing, runny nose, or sore throat not related to a pre-existing illness or health condition or to a known exposure to COVID-19
- Attendees must bring their own Personal Protective Equipment (PPE) i.e. mask and gloves
- Attendees must bring their own disinfecting wipes and hand sanitizer
- Attendees must maintain SPD of at least 2 metres from others at all times, including after scheduled ride times, unless they are from the same household
- Provide your own tools, implements, chairs, buckets, rakes, etc.
- Attendees are asked to respectfully limit after hours gatherings and maintain SPD at all times.

***This event is being held at Alhambra Stables in Red Deer, Alberta. It is necessary for attendees to agree to the following prior to arrival at Alhambra Stables:***

- No Entry is allowed to the wash rack, office or other private premises
- Access is allowed to the Shavings, Manure Pile
- Spectators must bring their own chair if they wish to sit and spectate.
- You must not use equipment from Alhambra
- Outdoor stabling is permitted. You must bring your stall guard. Stabling will be allocated by the organizer. Stalls will be assigned ahead of time.
- No vehicle access to the "al fresco" area.
- Trucks/trailers must be parked in the parking area, with a generous distance between each vehicle.
- Port-a-Potties will be on site. Sanitizer will be in place, at this location. PLEASE wipe things down before and after you use the bathroom. Best bet is to use your trailer
- Water will be made available, Gloves must be worn when using the tap or the tap must be sanitized before and after use
- Riders will be parked at the stabling near the road unless staying for multiple days. Those staying multiple days will be parking down by stable yard and their horses stabled in the "al fresco"
- Volunteers will be parked down by the parking close to stable yard and will have their assignments ahead of time.
- All paperwork will be done ahead of time by email.
- Rewards will be mailed out to you and there will be no ceremony.
- Show office will be outside for any questions under assigned tent cover close to cottage and scoring office
- Food truck with small menu will be on site by the cottage, No tables. Cash Only
- Extreme Tack is the main sponsor, please contact them for any items you might need, the store will not be on site, but they can bring items as requested. Please thank them for being our main sponsor.
